Submission Procedure:

1 To enter the competition, each participant or participating team would deliver a DVD containing the original working file of the Infographic/videographic to:

- 2 Submissions for Infographic may be in .pdf, .jpg or .gif, file formats. All submissions must be copied into a DVD along with the original working files (.air, .in, .esp, .PSD, etc).
- 3 Submissions for videographic may be in .mpeg, .mpg, .wmv, or .mov, file formats. All submissions are to be copied into a DVD along with the original working files (Adobe Premier Pro, Adobe Aftereffects, Maya, etc). Adobe after effects and Premier Pro files should be compatible with CS 6 or CS 5.5.
- 4 The submission ought to reach the above address **no later than 5pm on 30 April 2014.** Late submission will not be accepted by the committee.

General Terms and Conditions

- 5 By submitting an entry, the user is accepting the terms & conditions lay out in this section of the document.
- 6 In submitting an entry for 'VISUAL.STATS@MOM' Infographic/videographic competition, you undertake and agree to be bound as follows:
